Background

For nearly three decades, Nettlebed Surgery has stood apart from the norm by nurturing a close-knit environment reminiscent of traditional family practices. Led by Dr. Silver and Dr. Barton, Nettlebed Surgery has epitomised the cherished dynamic of the family doctor. Yet, the landscape of general practice is shifting.

According to the British Journal of General Practice in order to be sustainable the UK healthcare system requires that about 50% of new UK-trained graduates in medicine need to enter family medicine as GPs. In reality only 20% of UK medical graduates have elected for General Practice as their first choice of future career. This percentage has been largely unchanged over recent years. Alongside this there are retention problems with the GP workforce, with increasing numbers of GPs choosing to leave.

Against this difficult background Dr Silver and Dr Barton were seeking to relinquish Partnership to someone who they could be confident held the same values as they do. This is why they selected Dr Ravpreet Kaur. There are other avenues that Dr Kaur could have chosen to pursue in her career, but she believes in General Practice; she cares about her patients' health and wellbeing; she believes in the importance of family and the concept of a family doctor. Dr Kaur believed that with the help of the previous partners, who moved to become Salaried GPs, Nettlebed Surgery could continue as the successful small family practice it has always been.

Dr. Kaur's investment goes beyond the financial; it is a pledge to sustain the legacy of personalised care that has long been the hallmark.

As we navigate these times, the disparity between expenditure and income has become more pronounced. Nonetheless, the resolve within our team has only strengthened, as we continue striving to provide exceptional care in the face of adversity.

How Practices are Funded

For those that are unaware, GP practices are independent businesses. The premises, its upkeep, day to day expenditure in providing the services, including staff costs (Salaried GPs, nurses, other healthcare professionals and administration staff) are borne by the Partners who own the business. In the case of Nettlebed Surgery, this is now Dr Kaur.

The practice receives income from the NHS for supply of the services. However this is against a national formula. Over the years however income has failed to keep pace with expenditure – a sentiment that we know will be shared by our many patients involved in running a business or managing a household budget.

Partners do not receive a salary. Their 'pay' is dependent on drawings from the 'business' i.e. income minus expenditure.

Decisions

In the immediate future, recalibrating our finances will necessitate tough decisions, involving a strategic review with external consultants, and leaning on the patience and support of our patients and staff. We express profound thanks to our team members, who have demonstrated remarkable dedication during this challenging period, despite the potential impact on staffing.

To date, the impact has been the reduction of three part-time nursing roles through voluntary and necessary redundancies (the equivalent of 0.75FTE). While it's with a heavy heart that we consider further reductions, it is crucial to underscore that these measures are being taken to ensure the long-term sustainability of our practice.

We wish to reassure our patients that the total number of clinical sessions will not be compromised and will remain consistent with the model that has been in place since 2021.

These changes, although difficult, are pivotal in positioning Nettlebed Surgery for continued provision of quality healthcare in the years to come.

We are aware that we are not alone in facing these decisions, similar trends have been observed in healthcare practices nationwide.

Summary

At the core of our practice lies an unwavering commitment to the health and wellbeing of our patients and the dedicated team that serves them. Amidst ongoing deliberations to chart the best course forward, Dr. Kaur's resolve to ensure the longevity and integrity of Nettlebed Surgery is as steadfast as ever.

Our staff continue to demonstrate remarkable commitment, going above and beyond to meet our patients' needs under challenging circumstances.
